
We welcome additional ideas for speakers, vendor visits, technical topics, judging sessions and other events, which may be passed along to any Board member.

TECHNICAL CORNER

February 2020 Having you Corvette judged for operations?

When having your Corvette judged you are required to meet various levels of functionality depending on the award you are trying to achieve. The following is intended to give you the owner a basic understanding of the differences in the functionality (operations) of the various awards.

Flight judging Operations

Judging operations for flight judged cars is based on the ability of the car to perform the various functions as identified on the Operations Score Sheet. The items are judged on performance as expected at the time of delivery to the customer, no better, and no worse. There are no provisions for any repair or adjustment to any part or function once the car is placed on the judging field. The owner is expected to perform the operation of each line item as directed by the judges.

The Judging Score Sheet has multiple line items and may have multiple components for the line item. Each line has a maximum of 25 points. The 25 points may be allocated to the components of the line. For example the line item "Headlights" has a 25 point value, however there are multiple components, low beam and high beam, left and right side, points would be appropriately allocated as follows: low beam driver side 6 points, high beam driver side 6 points and low beam passenger side 6 points and high beam passenger side 6 points. That being said, a driver side single low beam not functioning properly would receive a 6-point deduction since there is no provision for a partial point the deduction is rounded to the nearest whole number.

Remember that all items must function as intended, so if a mid-year has a manual choke operated from the inside of the car, a full deduction, 25 points would be expected, since a mid-year Corvette would not also, a line item or component of a line item that is missing would receive a full deduction.

10 bonus points flight judging may be awarded to the total judging points for the presents of a fire extinguisher, NCRS decal, and a battery cut-off switch. If all are present a 10-point bonus would be added, if less than three than 3 points are awarded for each of those that are present.

Founders Award Operations

Founder's Award judging is similar to Flight Judging and is based on the operational functions of the item. Function being the keyword, the individual line item or component of the line item does not need to correct for the year but must open rate as intended if installed. For example, a cassette radio has replaced a Wonder bar radio, a quartz clock has replaced a mechanical clock, etc. as long as these replacement items are installed and function as intended than there would be no deduction for the operation. The same Judging Score Sheets used for flight judging are used for Founder's. There is a minimum score of 96% of the total points available that must be ackieved to get the award.

There are no provisions for any repair or adjustment to any part or function once the car is placed on the judging field. The owner is expected to perform the operation of each line item as directed by the judges. Many times, the judges will be assisted by the youth members of NCRS.

As in flight judging 10 bonus points flight judging may be awarded to the total judging points for the presents of a fire extinguisher, NCRS decal, and a battery cut-off switch. If all are present a 10-point bonus would be added, if less than three than 3 points are awarded for each of those that are present.

Performance Verification

The purpose of this test is to determine if the Corvette being judged is correctly equipped and able to fully function and perform as designed, intended and expected when new. Judging is conducted on a pass/fail basis. All items (approx.167) must pass.

A single malfunction during the judging will cause the judging to stop at the point. The owner will be allowed a 15-minute period to correct the malfunction. If the malfunction cannot be completed in the allotted time period, the judging of the car will stop, and the car will fail. In the event that the item malfunctions during the road test portion of judging repairs or replacement may take place on the road if feasible and safe. The owner will be allowed 15 minutes to correct the malfunction. If the item cannot be repaired or replaced during the road test the judging may continue at the judge's discretion (unless there is a safety issue) and the owner will be allowed 15 minutes upon return to the judging field to correct the item that malfunctioned. If the item has been successfully corrected within the 15-minute time allotted. The road test portion of the judging will resume from the point of failure, not from the beginning. If the item cannot be corrected, then the judging will stop, and the car will fail. Any line item that fails may be repaired or replaced with a spare part belonging to the owner, borrowed parts are not permitted or to be used to correct the malfunction.

Example: If a fuel gauge or temperature gauge should malfunction during the road test, the judge may allow the test to continue and allow the gauge to be corrected upon return to the judging field. If the judge **electsto stop the road test at the point of malfunction, then upon** successful repair the road test would continue from the point of the malfunction.

As mentioned, there is an allowance to repair or replace one item on the Performance Verification Score Sheet. In the event a second item or the same item that malfunctions previously malfunctions the test will stop, and the car will fail.

Concourse Operations

Although rather new to NCRS at this point in time (not all classes have been approved for judging) Concourse Operations judging has been incorporated into the NCRS judging format. The Concourse Operations Judging Score Sheets are similar to flight judging and deductions for items follow the same basic guidelines. The functionality of the line items must perform as the owner has intended or expected based on the characteristics of the line item. The items may or may not appear as the item from the factory and may or may not function in a similar fashion, but they must work. Missing item are

acceptable provided the area in which the item would have been has been substituted with another item or has been changed so as to not leave an unfinished appearance.

Example: A remote door opener installed in place of a typical style door handle on a mid-year, although not correct for flight judging is acceptable for Concourse. If present, the item must function as expected or intended (the door must operate with the remote). If there is a Television installed in the interior, the television must work (display a picture and change channels, etc.). If, for example a radio was deleted and the opening for the radio was not replaced with something else or finished to appear as though a radio was never present then a full or partial deduction would be appropriate.

My parents were together for 51 years, that's a lot of different changes to the Corvette, new technology, new body styles, and bigger engines.

My mom played such a crucial part in many major Corvette shows throughout the years, beginning as a tabulator and then transitioning to leading and organizing events such as Corvettes at Carlisle NCRS Gallery, Run for the Ribbons and many regional and national events. She always went above and beyond running every Corvette event like a well-oiled machine and took charge to ensure the



shows ran without a hitch. She co-chaired the NCRS Gallery at Corvettes at Carlisle, a special collection of Corvettes, with Frank Stech for 19 years and has been a major part of organizing the Run for the Ribbons the last 39 years. If you do the math, she made an impact on thousands of people. She was a pioneer in promoting and further progressing awareness and community of the Corvette hobby.

My morn had a passion for Corvettes but what she was most known for was the kindness and generosity she shared. She always enjoyed Corvettes but what she loved most was the community she helped support and build. She would go out of her way to ensure people were included, remembered someone's anniversary, supported someone going through a difficult time, spreading kindness wherever needed. She was a doer, not just saying "Please let me know if you need anything." But rather, she always knew exactly what people needed, whether it was bringing someone a meal, arranging someone to get to a Corvette show, gathering the community together to support one of our own. She truly did it all.

As we all continue to grieve and move forward from our loss of my mom, I want to ensure my mom's memory continues on. I ask everyone to do 2 things. First, continue to promote and grow the Corvette hobby just as she did by volunteering at Corvette shows, serving on your chapter board, hosting seminars, etc. Find a way a way to get involved with NCRS. Secondly, go spread kindness. Instead of saying "let me know what I can do to help." go be a doer, figure out how you can help someone, how you can make someone's day brighter and go do it. Let's all continue what she always set out to do, spreading kindness.

REMEMBERENCES OF OUR 2001 REGIONAL

The picture above was taken from the top of the Woodbridge Hilton in Woodbridge, NJ. The Woodbridge Hilton was the host hotel for our first NE Regional hosted by the Central New Jersey Chapter of the NCRS in 2001. It shows the vastness and expanse of the judging field that was used for judging at this event. I estimate that approximately 100 Corvettes registered for flight judging. The number of registered cars was of the same order of magnitude that attended the NCRS National that year.

It was a very successful event despite the fact that it poured rain the first day of registration. We all felt sorry for the volunteer staff that was responsible for directing car and trailer parking in the rain all day! The national board members were all on hand to observe, help and guide us, and make sure things went smoothly considering that we were a small and new chapter and this was our first regional. But all went extremely well thanks to the hard work of our volunteers and our Judging Chairman Vito Cimilluca and registrar Elizabeth Meyer. By the way, at that time, I happened to be treasurer for this event.

Although the show went well all was not perfect since the twin towers in NYC were attacked a week before our regional. The event schedule for the regional included bus tours to various NYC sites but they had to be cancelled as a result and were rescheduled to go the New Hope Pa. instead. The CNJ Chapter of NCRS collected approximately \$1000 in donations to help the victims of that attack.
