


Laser Printing Introduced to the 1996 Corvette

During my research pertaining to the Paint Code for the 1996 Collector's Edition I came across a Bulletin from General Motors advising of a change in the positing of various Service Parts Identification Labels (SPID). In examining this Bulletin it was discovered that the photos showing the positing of the Labels/Decals displayed a different type of Label/Decal than previously used by Chevrolet. In contacting the Corvette Plant in Bowling Green it was determined that in October/November 1995 Chevrolet went to the Laser Method of printing their Labels/Decals. At first I thought that this only pertained to the Service Parts Identification Label.

The below photo depicts the older type Label/Decal that was utilized on the Corvette for many years. The Laser Label/Decal appears on the next page and you can see the difference right away. There is no confusing the two.

I thought that after the completion of the review of the Service Parts Identification Label issue I would no longer have any further association to the new Laser method of Printing by Chevrolet. I was wrong in that assumption, as I was to find out.

Also during the time I was conducting my review of the information pertaining to the Paint Code of the 1996 Collector Edition I was asked to look into the deletion in 1996 of the Mobil One Label that was present under the hood of previous model year Corvettes.



For a number of years this Label was present and is a judged item. When the 1996 Corvette entered the flight judging process information was being sent to the National Judging Chairman that 1996 Corvettes were showing up on the flight judging field without this Label. I began to look into this and found that the Mobil One Label was present on all 1995 Corvettes. However, in examining the 1996 Model Year I discovered that the early units had this Label, but around October/ November they were no longer affixed to the area under the hood and were not present in any other location. I have about 50 1996 units in my data base and it is readily apparent that the date correlates with the date of the deletion of this Label. The last VIN that I have in the data base with the Label is 2654 and the first VIN that does not have the Label in my data base is 3585. There have been a couple of occurrences where a unit after VIN 3585 displays a Mobil One Label, but the feeling is that the owner may have placed it there because the 1994-96 Judging Manual called for one to be present. It appears that the deletion of this Label coincided with the change in the Service Parts Identification Label printing method. (ed. note: Mobil Petroleum had a brilliant marketing idea to boost sales of the newly introduced synthetic oil. If Chevrolet would allow placement of the Mobil One logo under the hood of each new Corvette, Mobil would provide all the synthetic oil to Bowling Green free of charge. The net result is that the placement of their logo suggested to the owner that Mobil One was the only motor oil approved for use in Corvettes).

The changeover to the laser print method included the Federal Certification label and tire information label affixed to the driver's side door jamb as well as the Service Parts Identification Label. The following illustrations depict the differences in the laser version compared to the previous printing method.

And the laser printed version of the same labels



The differences are readily apparent. The 1994-96 Judging Manual only displays the older type of Build Label and not the newer version. Another interesting fact was that the older style Labels had a part number, wherein the newer Labels did not. Also the newer labels have the VIN appearing on both labels, wherein the old style only displayed the VIN once on the Federal Certification Label.

I have created a new data base in an effort to see if any 1996 Corvette has a mixture of these Label changes and to date I have not located a single unit. All the units that I have examined have either the old style or the new style labels and not a mixture of each. I did observe one of the later 1996 Corvettes that had a Mobil One Label and also laser labels suggests my speculation that the owner had added the Mobil One Label to conform to the judging manual.



Penetrating Oils

Machinist's Workshop Magazine recently published some information on various penetrating oils that was very interesting. Some of you might appreciate this. The magazine reports that they tested penetrates for break out torque on rusted nuts. They are below, as forwarded by an ex-student and professional machinist. They arranged a subjective test of all the popular penetrates with the control being the torque required to remove the nut from a "scientifically rusted" environment.

Penetrating oils Average torque load to loosen

No Oil used	
WD-40	238 pounds
PB Blaster	214 pounds
Liquid Wrench	127 pounds
Kano Kroil	106 pounds
ATF*-Acetone mix	53 pounds

The ATF-Acetone mix is a "home brew" mix of 50 - 50 automatic transmission fluid and acetone. Note this "home brew" released bolts better than any commercial product in this one particular test. Our local machinist group mixed up a batch and we all now use it with equally good results. Note also that "Liquid Wrench" is almost as good as "Kroil" for about 20% of the price. Steve from Godwin-Singer says that ATF-Acetone mix is best, but you can also use ATF and lacquer thinner in a 50-50 mix.

The business meeting scheduled for August 18, 2014 held at the Hightstown Elks Club was called to order at 8:00 pm. The number in attendance was 19.

The meeting opened with Ed thanking those in attendance for coming.

The secretary was called upon to read the minutes from the June meeting. They were accepted as read.

Richard gave the treasure's report. The balance of our combined accounts is \$21,560.28 of which \$20,279.50 was from our savings account. The operating account has gone from \$1,505.52 down to \$1,280.78. The expenses for the month were the food for the picnic \$625.89, hall rental fee \$100, Annual Web hosting fee \$66.95 and a refund for a meet registration \$75.00. The income which offset most of the expenses was from a few membership dues collected and registration fees for our chapter meet. The increase of \$1.35 to our savings account was due to the interest earned. The Treasures report was accepted as read.

Howard was then called upon to give the Vice Chairman's report. He began with thanking those members who participated in the events on July 26th. We had forty plus people at the picnic, 14 cars participated in the road tour and 17 members attended the judging school. Ed commented on what a nice day it was for the event. He thanked Dottie and Jim for being gracious hosts and Howard for his in depth presentation on the 67 judging manual. The two remaining events for this year will be the chapter meet in September and the holiday brunch which will be held on December 14th. Howard asked those in attendance to consider attending the brunch and a head count will be taken during our October meeting. The per person cost for the brunch should remain the same as last year. A member in attendance then asked Howard for the status on the road tour to The Simone Museum. Howard informed the members that the next road tour would be conducted in the spring. His first preference would be a tour to Callaway Cars but if arrangements could not be made, he would look at The Simone Museum. Ed and Howard asked everyone in attendance for ideas on events for next year. Someone suggested visiting F40 Motorsports in Portland, CT which hosts a car show each month. They will gather the information and present it to be considered for next year's road tour. Ed mentioned that it appears that more NCRS members are becoming interested in the newer cars and that maybe we should look at hosting events geared towards them.

Dave was asked for the status on our chapter's meet in September. Dave first gave confirmation that John Kuhn will be conducting the tech session in October on the updates to his C1 project and his new project on a 1963 convertible. Dave also mentioned that he had heard from Dave Brigham in regards to the judging clinic that was conducted in July. According to Dave Brigham the session should not have taken place because of the two week blackout before and after the National Meet. This rule has not been strictly enforced but will be the feature of a future article in The Driveline Magazine to remind all the chapters. The points will be given to the members that attended the clinic. Dave then gave the details of our chapter meet. We have nine cars and ten judges officially registered for the event. Dave sent an email to the Del Val, Metro Long Island and Mason Dixon chapters requesting judges to volunteer. Dave and Ed suggested to the members in

Attendance that if they are planning to attend the meet, they should consider registering to be a judge. They stated that no matter what judging level one is on, it is a great way to get involved and understand the judging process. Only Elizabeth Meyer has volunteered to be a tabulator and Elaine Raisner may step in if needed. Two additional areas that still need some assistance are parking to help Ed Lepelis and arranging the food to work with Joe Bardon. The board ended with a quick review of the scheduled events for that day.

Ed opened a discussion on the National in Kansas City. He asked the members who had attended to share their experience. They discussed how the road tour to the event went well with very interesting stops along the way. Some of the stops included The National Corvette Museum and the Corvette Assembly Plant. Ed has reached out to the National for a list of members from our chapter that won awards. Next year's National will be held in Denver. Collecting the dues has become a thorn in the side of the members on the board. We will begin collecting dues in November. Dues remain at \$30. All members that do not pay by April will be removed from the roster. We are planning to move the meetings to different locations next year. One meeting may be held at Princeton Chevrolet and one at Woodbridge Community Center with Vito. We are also looking at the nearby American Legion Hall and staying with the Elks Club. Ed will send monthly reminders on the status of each meeting and confirm its location. This information will also be posted to the calendar on our chapter's website. Two members will have their cars displayed at the NCRS Gallery in Carlisle and all of the members attending were encouraged to stop in. The winter regional has moved to a new location. It will be held in Lakeland, Fl. Ed introduced Nick, a new chapter member. Nick stood up and spoke briefly about his 67 that he has been restoring. Ed then opened the floor for general discussions and the member contribution for the hall rental fee was collected.

The meeting was adjourned at 9:15 pm.


Central New Jersey Annual Road Tour & Picnic
